SERVICE AGREEMENT

This Agreement is between **Westwood Books Publishing LLC** (Company) and **Name** (Author) for the work or book/s titled **Book Title**. Said parties entered into this Agreement on this date, **June **, 2021**; WHEREAS,

General Terms and Conditions:

1. The author agrees to publish and/or market the work and grants **Westwood Books Publishing LLC** the nonexclusive right to print, advertise, distribute and sell, and ship the work in any way the Company deems appropriate, and grants the Company the right to distribute the work worldwide, and collect all monies for books sold by it and to give the author his or her share from the book-sales; **Westwood Books Publishing LLC** agrees to pay royalties on a quarterly basis to the author, beginning with the last day of the first full month of publication;
2. It is the author's responsibility to submit his or her book file to us in a format consistent with the guidelines set forth in our Submissions Guidelines. Failure to do so may incur in additional services and charges. **Westwood Books Publishing LLC** will assess the manuscript for consistent formatting within a reasonable time-frame and will notify the author of any potential problems associated with the content or formatting. The author will be given the choice of having the file returned to them to make the adjustments or the Company will provide additional services to modify the manuscript for prepublication;
3. **Westwood Books Publishing LLC** retains the right to determine the appearance of all online presentation including but not limited to, online marketing, listing, and eBook appearance and the like;
4. **Westwood Books Publishing LLC** will make sure that in order to avoid poor submission of work, publishing guidelines and standards shall be followed at all times. The Company will not be liable to the author or any other person/entity for lost profits or revenues due to or in connection with poor submission of work;
5. **Westwood Books Publishing LLC** is not and will not be held liable to the author for any loss or misplacement of the published or unpublished work for any reason. It is the author's responsibility to retain complete records and copies of all materials/files relating to it pre and post publication;
6. **Westwood Books Publishing LLC** and the **Author** cannot amend agreement after signed and paid;
7. The author can submit his/her own interior and cover design for the book and that we will not be making changes on it without her approval, provided that such work is fully owned by the author or if he/she has full permission to use without any copyright infringement.

10. **Author** retains the right to establish the discounted price to all purchasers and consumers of the book, including, but not limited to distributors, bookstores, schools, libraries, and quantity purchasers;
11. **Westwood Books Publishing LLC** will not be held responsible for errors in the book, including, but not limited to, spelling errors, grammar, punctuation, style of work, page numbering, corrupted files, computer formatting errors, and missing fonts. The company will issue a printed copy to the author after the galley approval for him/her to see the physical aspect of the book. Should the author wish to modify any error(s) in the printed copy, it will be subject to a resubmission fee. The Company has the right to reject any work for any reason at any time;
12. Upon the approval by the author, **Westwood Books Publishing LLC** will submit the work to multiple distribution channels including retailers, websites, etc., but will not be liable for delays, errors, non-compliance of such distributors, suppliers, e-retailers, etc. Royalty statements shall be sent on a quarterly basis to the author via email only. A check replacement fee (for lost checks by author) will be charged to replace any previously issued Royalty payment;
13. The Company provides a full return policy within one year of purchase to bookstores at no charge to the author. Under this "Bookstore Returnability" Program, bookstore owners can return unsold copies of author's books to the Company at no deduction to the author in royalty payments;
14. The Company reserves the right to limit the number of books a bookstore may purchase at one time for any single event under our return policy;
15. The Company is not responsible for, but will endeavor to care for and return, submitted photos and artwork by the author; and may not return any submitted CDs, floppy disks, or thumb/flash drives;

Author Responsibilities:

16. The author maintains that he or she is the author of the work and owner of the copyright, all of the contents thereof and has full power to enter into this Publishing or Marketing Agreement; that he or she has not engaged in plagiarism with respect to the work; and that the author in submitting work that includes any content that does not originate from the author or to which the author does not own the copyright to, has obtained the copyright owner's written permission to use any such material and will provide **Westwood Books Publishing LLC** with a copy of all written permissions for use at the time of submission. And that all such uses will be so noted in the work; and will send a copy of the Copyright Form to the Company after the form has been stamped and returned to the author by the Library of Congress;
17. The author guarantees the Company that the work is accurate, is not in violation of anyone's privacy, is not injurious, obscene, libelous, slanderous, or otherwise a violation or infringement of any federal, state, or local law, statute, or code, and further agrees to hold **Westwood Books Publishing LLC**, its employees, directors, shareholders, representatives, heirs and assigns, harmless for any damages resulting from any litigation resulting from publication of the work;
18. The author further guarantees the Company that the work, if fiction, does not include the name and/or likeness of any actual person, living or dead; and that all characters in the fictional work who may have been derived from actual persons have altered names and altered physical attributes, so as to negate any similarity or likeness between the actual person, location, or event, and the fictional character or location,

19. The author agrees that Westwood Books Publishing, LLC shall ensure the accuracy and reliability of the information provided on this galley. Furthermore, the company reserves the right to limit the rounds of corrections per package as follows:
- Oak Publishing Package - 2 rounds of corrections
 - Maple Publishing Package – 2 rounds of corrections
 - Walnut Publishing Package – 3 rounds of corrections
 - Mahogany Publishing Package – Unlimited rounds of corrections

Thus, transcending to the stated rounds will be subject to a fee. The author shall be solely responsible for determining whether its error has been modified. We assumed that you have thoroughly examined the galley upon your approval thus we should not be held liable for any errors or whatsoever subsequently.

20. When we have created the work, we will provide you with an electronic copy for your complete and thorough review prior to publication. If, upon review, you are satisfied that each and every aspect of the work is accurate, complete and meets your expectations, and you acknowledge and accept the Suggested Retail Price, you will sign all requested forms to indicate your final approval and return them to us in a timely manner. After your final approval is given, you waive any and all claims against us or our contractors arising from or related to any alleged errors, omissions or other content or pricing issues discovered in the work after final approval. You are responsible for the Fees for any subsequent changes, corrections or other Services requested by you after final approval.
21. The author agrees that the Company is not responsible for editing, misspelling, and rewriting, page-numbering, indexing, reviewing, or any other errors in the work unless his service requires it so;
22. The author understands that the Company will take the author's digital book file and do its best to fix any obvious problems resulting from the file being transferred to the Company's computers before sending the author a first proof book; and that any changes made to the book thereafter, regardless of their origin, will be made at the author's request;

 - After submission of Your Manuscript but before design work begins: 50% of purchase price
 - After design work begins but prior to final approval: 25% of purchase price
 - After You have given final approval of the Work:
 - No Refund
 - NOTE: Submission of Your Manuscript occurs when You first deliver to Us any text or images intended for publication.
 - 15 days and beyond after payment of service or product,
 - No Refund

30. Any and all legal actions arising from this agreement or towards the Company shall be filed solely in the State of Florida USA only;
31. If there is more than one author contribution to the work listed in this Agreement, the authors must provide ONE point of contact. -If royalties are being paid to more than one author, each author's royalty calculation will be reduced by 1% by the Company for administration costs. -If royalties are being paid to more than one author, **Westwood Books Publishing LLC** requires each author to complete a separate General Provisions section -A separate publishing agreement must be completed for each individual title being submitted.
